Color at 20°C - dark brown;

Consistency at a temperature of 20 ° C - liquid;

Mass fraction of moisture - no more than 3.5%;

Splitting depth - not less than 60%;

Mass fraction of unsaponifiable substances - no more than 6.0%;

The presence of sulfuric acid is not allowed.

- Vegetable oil soap stock (TN VED code 1522009100):

Color at a temperature of 20 ° C - from yellow to brown;

Consistency at a temperature of 20 ° C - liquid and ointment;

The smell is specific, characteristic of soap stock obtained from various oils and fats;

Extraneous solid impurities - no;

Mass fraction of total fat - not less than 20%;

Mass fraction of fatty acids - not less than 12%.
